Expert Witness Workshop & Mock Trial 2023 MOCK STORYLINE

Hurricane Calamity strikes Houston, Texas on September 1, 2021.

Mr. and Mrs. Owniere own a multimillion dollar home along Blues Bayou and it floods with two feet of water. They also own a jewelry store that is burglarized during the aftermath when the city suffers extended power outages. Additionally, their small metal fabrication business is disrupted and disabled when equipment is damaged from a collapsed roof. To make matters worse, Mr. Owniere is excluded from a business he owns, from the actions of his three partners. As the recovery and rebuilding progress, the Ownieres find themselves dealing with insurance claim disputes, percentages of ownership for one business, bankruptcy of another, and questionable actions by Trust officers.

Various lawsuits require the specializations and knowledge from expert witnesses, and each testifies in the progression from mediations, to depositions, to testifying at trial in the courtroom. A personal property appraisal is submitted for damaged furniture at the residence, and is the subject of an appraisal review to conclude an opinion of compliance with a professional appraisal standard of care.

Attorneys, expert witnesses, insurance representatives, trust officers, business valuation, machinery and equipment appraisals, personal property appraisal review, gems and jewelry values—and more are involved.

Guess what? You got it! ... These litigation assignments are fictional and not true. All names, companies, properties, and details are fabricated. Viewers and attendees are advised to understand everything is made up, because everything is made up.

Get ready for some fun in mediation, then in depositions, and finally in the courtroom with live, unscripted action!

Mediation Education— What it is, and What is Not The Role of the Expert Witness in Mediation Assignments



Denise Peterson is a full-time mediator, arbitrator, and occasional professor at South Texas College of Law, her alma mater. Mr. and Mrs. Owniere own a small metal fabrication shop that owns computer numerical control (CNC) equipment, which is equipment that precision cuts metal to a specific limit, and sells to the finished products to various industrial end users. The manufacturing equipment is damaged during the hurricane when the roof is blown off of the building, and the equipment is damaged. The business fails and the couple file for bankruptcy. The damaged equipment is valued by Horacio Correa, of Correa Appraisal LLC, for a liquidation sale using a Fair Market Value. The creditor's appraisal is much different than the owners' and the owners need a credible valuation for the 30+ year old equipment, instead of the higher values claimed by the bank.

The aftermath of a hurricane leaves more than physical destruction, as businesses are vulnerable to theft when power outages last for weeks. Mr. & Mrs. Owniere own a small jewelry store that is burglarized and various jewelry items are stolen. Christine York, of Christine York Jewelry & Appraisal LLC, values a David Webb designed pendant/brooch set with a large center carved cabochon emerald, accented with a fancy surround of round cut diamonds, together with smaller emerald cabochons, sapphires, and rubies. The lawsuit ensues for insurance claim disagreements. Ms. York is hired by the insurance company and appraises the set, concluding a Replacement Value.

Mr. Owniere is one of four partners in a business, Specialty Contractor Services LLC, each owning 25% of the company. On August 27, 2021, soon before Hurricane Calamity struck Houston, the other three partners accepted Mr. Owneire's resignation from the company, but he never submitted a resignation – verbally or in writing. He is locked-out of the company and is blocked from conducting all business. His legal counsel hires Scott Miller, owner of Convergent Capital Appraisers, and Mr. Miller values his 25% interest in the company in the context of the Fair Value standard of value, as prescribed by the Texas Business Organizations Code.

Furniture must be replaced according to their insurance policy. The couple hires Melanie Modica, of Modica Fine Art LLC to provide an appraisal review for the report submitted by the appraiser hired by the insurance company. The Ownieres collection is not properly identified in the appraisal from the insurance company. Ms. Modica measures the work under review for compliance with the Uniform Standards of Professional Appraisal Practice and concludes it is not a credible appraisal report, and not worthy of belief.

Mr. and Mrs. Ownier own a multimillion-dollar home, in a Trust, that was originally purchased for \$4,000,000.00 two years before the hurricane. The trust officer had the property appraised at the time of purchase and the opinion of value supported the sales price, which is the amount the Trust paid to buy the home. After flooding in 2 feet of water during the hurricane, \$1,000,000.00 of repairs are made to the home. Two years have passed and Mr. & Mrs. Ownieres have tragically died in a small aircraft crash. Their sole heir and beneficiary is their only nephew, Sam Lucky. The Trust officer has the property valued again and sells it. Mr. Lucky contends the house was sold for less than it was worth, and contends the actions of the Trust officer, and enters into a lawsuit against the financial institution, which is the Trustee. To assist in Trust management, Real Estate Appraiser Jeffrey Hays, of J & J Hays, Inc. is hired by the Trustee to complete appraisals of the property for the purchase, and again after the flood. Each appraisal provides a market value opinion of the property.

An antique Parure Suite consisting of a necklace, pendant, brooch, earrings, and tiara, all handmade, were taken from their jewelry business when power outages left it vulnerable to burglars. The whole set is stolen and an insurance claim is filed. Ms. Lawch is hired by Mr. and Mrs. Owniere and values the Suite for a replacement value. The insurance company states it will replace the individual items and piecemeal a set together, instead replacing the property with another original set. A non-original set of mismatched items will greatly affect the value.
